6th Meeting of the IAC Consultative Committee of Experts

The 6th Meeting of the IAC Consultative Committee of Experts (CCE) took place via video conference, on March 13-15, 2013. This was the first time the modern technology of video conference was used with the intention of increasing the participation and significantly reducing the costs for the IAC Party countries. This technology successfully resulted in the attendance of 10 countries and representatives from the scientific, NGO and private and productive sectors. Below is a summary of its results:

- The 2013-2014 CCE Work Plan was updated.
- A draft Resolution on the “Economic Subsistence Exceptions under Article IV (3 a and b) of the Text of the IAC Convention by Guatemala and Panama for *Lepidochelys olivacea* Egg Harvesting” was prepared to be presented at the 6th Conference of the Parties (COP6).
- The document “Guidelines for Preparing Sea Turtle Action Plans for IAC Party Countries” was approved and will be presented to the COP6 in the form of a technical document.
- A report on the Compliance by Party Countries with IAC Resolutions was prepared and will be presented at the COP6.
- The task force for the recovery of the Eastern Pacific leatherback prepared a report and recommendations to the COP6 on how to improve compliance with the Resolution on leatherback turtle conservation (CITCOP2-2004-R1).

We would like to thank the Department of State of the United States of American government for organizing the video conference from their office and Mr. Paul Hoetjes, Chair and Mr. Joca Thomé, Vice-Chair of the CCE for their guidance in producing solid documents that will be taken to the next Conference of the Parties for discussion. Climate Change and Sea Turtles

During the fifth meeting of the IAC Consultative Committee of Experts, the Committee analyzed compliance with IAC Resolutions and noted a low level of compliance with Resolution CIT-COP4-2009-R5: Adaptation of sea turtle habitats to climate change. The CCE5 recommended that the IAC Parties begin taking appropriate actions considering the possibility of available international resources and the work being done by organizations like WWF, which has become a leading organization on this topic.

Following-up on this recommendation, WWF provided the IAC with technical assistance in preparing an online survey in order to help us better understand the challenges faced by IAC Parties in implementing actions to monitor climate changes and its affects on sea turtles. We would like to thank those delegates of the Consultative and Scientific Committees who participated in our survey since, based on their results, the WWF expert Marianne Fish was able to give a webinar to the IAC Scientific and Consultative Committee members, which was held on March 18. The objective of this webinar was to identify specific activities that can be carried out in collaboration with WWF to guide IAC Parties on how to improve their implementation of the Climate Change Resolution. The following activities were proposed:

- ❖ Promote research and monitoring of sea turtles and their habitats
- ❖ Include marine and coastal habitats in climate change adaptation programs
- ❖ Identify and implement corrective measures and adaptation to climate change within management plans and sea turtle conservation
- ❖ Execute mitigation measures for non-climatic threats to improve the conservation status of sea turtle populations and their habitats so that they are better able to respond to the impacts of climate change
- ❖ Promote technological transfer and technical capacity between countries, other conventions and organizations involved in this topic within the area of the Convention

Achievements and Activities in the IAC Region

Economic Valuation of the Environmental Services Provided by the Caribbean Wetlands Used by Marine Turtles in Venezuela

Dr. Joaquín Buitrago of the Margarita marine research station, La Salle Foundation of Natural Sciences, identified the main functions of marine turtle life history that help maintain ecosystem services and presented options for their economic valuation, using data obtained along the Caribbean of Venezuela. Sharks and Manta Rays Receive Protection Under CITES

We congratulate our IAC delegate, Eduardo Espinoza, who represented Ecuador in the 16th Meeting of the [Conference of the Parties to CITES](#), that was held in Bangkok in March of 2013. The CITES Parties took decisive action to protect these vulnerable shark and ray species from over-exploitation for international trade and to help maintain sustainable fishery resources.



Puerto Rico Declared Leatherback Turtle Nesting Site Protected Area

The area, known as the [Northeast Ecological Corridor](#), covers more than 1,200 hectares (2,900 acres), which protect different types of ecosystems from subtropical dry forest to tropical rain forest in addition to being one of the most important nesting sites for the leatherback turtle (*Dermochelys coriacea*) in the United States. We congratulate our Puerto Rican colleagues who have supported this initiative for many years and made it a reality.

Sea Turtles at the Embassy Tour 2013 – Nicaraguan Embassy

The IAC received an invitation to participate in the “Embassy Tour –Nicaragua 2013” that was held on May 4th at the Nicaraguan Embassy in Washington, DC. During the event, informative brochures were handed out and videos were played on the protection and conservation of sea turtles in the IAC region. The Nicaraguan embassy received approximately 2,000 visitors during the occasion, which made it an excellent opportunity to educate the public and raise awareness to plight of sea turtles in the Americas.
